ABSTRAK

Penelitian ini bertujuan untuk menganalisis bagaimana proses pembentukan kata dari suatu istilah yang biasa digunakan pada lingkungan kerja bidang ekonomi yang ditemukan pada sebuah report yang dipublikasikan oleh World Economic Forum pada Januari 2021 dengan judul ‘Chief Economist Outlook 2021’. Secara spesifik, tujuan dari penelitian ini adalah untuk mengidentifikasi bagaimana proses pembentukan dari istilah yang sering digunakan pada bidang ekonomi yang ditemukan pada report tersebut, dan mengidentifikasikan jenis morfem pada istilah tersebut. Peneliti menggunakan dua teori untuk melakukan penelitian ini; yaitu teori oleh Yule dan Carstairs-McCarthy. Dalam penelitian ini, peneliti menggunakan metode deskriptif kualitatif. Data dikumpulkan dari sebuah report yang dipublikasikan pada Januari 2021. Hasil penelitian ini menunjukkan bahwa hanya empat proses pembentukan kata yang membentuk ke tigapuluh dua data yang ditemukan pada data source: compounding, derivation, borrowing dan acronym; derivation merupakan proses yang paling banyak membentuk term pada report tersebut sebanyak empat belas istilah, yang kedua adalah compounding sebanyak delapan istilah, ketiga adalah borrowing sebanyak enam istilah, yang terakhir adalah acronym sebanyak empat istilah yang terbentuk oleh proses tersebut. Untuk jenis morfem dari data yang berbentuk compounding dan derivation terdapat dua puluh tiga root, empat belas affix, dan dua combining form yang digunakan untuk membentuk istilah tersebut.

ABSTRACT

This study aims to analyze how the process of word formation from a term commonly used in the work environment in the economic field is found in a report published by the World Economic Forum published in January 2021 with the title 'Chief Economist Outlook 2021'. Specifically, the purpose of this research is to identify how the process of forming the terms often used in the economic field found in the report, and identify the kind of morphemes in those terms. Researchers used two theories to conduct this research; namely the theory by Yule and Carstairs-McCarthy. In this study, the researcher used a qualitative descriptive method. The data is collected from a report published in January 2021. The results of this study indicate that only four word formation processes make up the thirty-two data found in the data source: compounding, derivation, borrowing and acronyms; derivation is the process that forms the most terms in the report as many as fourteen terms, the second is compounding with eight terms, third is borrowing with six terms, the last one is acronyms with four terms formed by the process. For the kind of morpheme of data in the form of compounding and derivation, there are twenty-three roots, fourteen affixes, and two combining forms that are used to form the term.

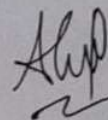
