ABSTRAK

Penelitian ini adalah penelitian pragmatic yang menyelediki hubungan antara bahasa dan konteksnya khususnya penggunaan strategi ketidaksopanan. Tujuan dari penelitian ini adalah untuk mengidentifikasi jenis-jenis strategi ketidaksopanan yang digunakan oleh para penutur di dalam film Ugly Betty serta untuk mengetahui faktor para penutur menggunakan strategi ketidaksopanan berdasarkan konteksnya tersebut. Penelitian ini adalah penelitian deskriptif kualitatif. Objek penelitiannya yaitu strategi ketidaksopanan di film Ugly Betty. Dalam pengumpulan data, peneliti menggunakan metode observasi dengan teknik simak libat bebas cakap. Dalam analisis, peneliti menggunakan metode padan pragmatics dari Sudaryanto (2015). Selanjutnya, teori Culpeper digunakan untuk menganalisis jenis strategi ketidaksopanan yang digunakan oleh para penutur serta didukung oleh teory Jay untuk menemukan faktor para penutur yang menggunakan strategi ketidaksopanan tersebut. Metode yang digunakan untuk presentasi hasil analisis adalah metode informal. Hasil penelitian menunjukkan bahwa strategi ketidaksopanan yang digunakan dalam film Ugly Betty yaitu ketidaksopanan secara langsung, ketidaksopanan positif, ketidaksopanan negatif, ketidaksopanan secara tidak langsung dan menahan kesopanan. Kemudian ada enam faktor yang mempengaruhi penutur di film Ugly Betty memilih kata ketidaksopanan. Faktor tersebut adalah faktor yang dipengaruhi oleh umur, jenis kelamin dimana penutur menggunakan kata tabu yang berhubungan dengan jenis kelamin, status sebagai kekuatan untuk melakukan etika yang tidak baik, dan melihat penampilan fisik, pengaturan social fisik dan juga diri sebagai pelanggar.

ABSTRACT

This research is a pragmatic study that investigates the relationship between language and its context, especially the use of impoliteness strategy. The purpose of this study to identify the types of impoliteness utterance used by speakers in the Ugly Betty Movie and to find out the factors of speakers using the impoliteness strategy based on the context. This research is a qualitative descriptive study. The object of the research is the impoliteness strategy in the Ugly Betty Movie. In collecting data, researchers used the observation method with the technique of nonparticipant. In the analysis, researchers used the pragmatics method by Sudaryanto (2015). Furthermore, the theory proposed by Culpeper used to analyze the types of impoliteness strategy by speakers and supported by theory proposed by Jay to find out the factors of speakers using these impoliteness strategies. The method used for presenting the results of the analysis is an informal method. The results showed that the impoliteness strategies used in Ugly Betty Movie are bald on record impoliteness, positive impoliteness, negative impoliteness, off-record impoliteness and withhold politeness. Then, there are six factors that influence the speakers in Ugly Betty Movie chose impoliteness strategy. These factors are factors influenced by age, sex where speakers use taboo words related to gender, status as a power to do bad attitude, and see physical appearance, physical-social setting and also self as wrongdoer.


