

ABSTRAK

Tindak tutur ilokusi komisif memuat keadaan-keadaan dimana perbuatan itu harus dilakukan atau tidak. Memahami tindak tutur ilokusi komisif penting untuk mengetahui apa yang dimaksud penutur dari tuturan yang muncul. Penelitian ini bertujuan untuk mengidentifikasi tindak dan fungsi tindak tutur ilokusi komisif. Penelitian ini menggunakan teori tentang tindak tutur ilokusi komisif dari Searle dan Vanderveken dan teori dari Leech tentang fungsi tindak tutur ilokusi komisif. Searle dan Vanderveken membedakan tujuh belas tindak tutur ilokusi komisif. Ada juga empat fungsi tindak tutur ilokusi komisif menurut Leech. Penelitian deskriptif kualitatif ini menggunakan metode observasi dan teknik mencatat. Penelitian ini juga menggunakan identitas pragmatis untuk menganalisis data. Hasil penelitian ini dijelaskan secara deskriptif dengan kalimat dan kata-kata. Dari hasil analisis, terdapat tiga belas tindak dan semua fungsi tindak tutur ilokusi komisif yang digunakan. Perbuatan itu adalah melakukan, berjanji, mengancam, bersumpah, menerima, menyetujui, menolak, menawarkan, meyakinkan, menjamin, kontrak, perjanjian, dan taruhan. Fungsinya adalah konflik, ramah, kompetitif dan kolaboratif. Dalam penelitian ini, tindakan yang paling banyak digunakan adalah persetujuan dan penolakan. Selain itu, fungsi yang paling banyak digunakan ramah. Itu karena film ini bukan hanya tentang pernikahan, tetapi juga tentang ketidakharmonisan hubungan antara anak perempuan dan ayah. Dan juga, film ini cenderung menampilkan ujaran-ujaran yang sejalan dengan tujuan sosial.

ABSTRACT

Commissive illocutionary speech act contained circumstances under which the actions must be performed or not. Understanding commissive illocutionary speech acts is important to know what the speaker means from the utterances that appeared. This research aimed at identifying the acts and functions of commissive illocutionary speech act. This research applied the theory about commissive illocutionary speech act from Searle and Vanderveken and theory from Leech about functions commissive illocutionary speech act. Searle and Vanderveken distinguished seventeen acts of commissive illocutionary speech act. There are also four functions of commissive illocutionary speech act according to Leech. This descriptive qualitative research used observational method and note-taking technique. This research also used pragmatic identity to analyze the data. The results of this research were explained descriptively by sentences and words. From the analysis results, there were thirteen acts and all functions of commissive illocutionary speech act that used. The acts were commit, promise, threaten, vow, accept, consent, refusal, offer, assure, guarantee, contract, covenant, and bet. The functions were conflictive, convivial, competitive and collaborative. In this research, the most used acts were offer and refusal. Moreover, the most used functions were convivial. That was because this movie was not just about a marriage, but also about the disharmony relationship between daughter and father. And also, this movie tended to show utterances that coincide with the social purpose.
