ABSTRAK

Eksistensialisme seringkali menjadi salah satu objek yang muncul dalam karya sastra dan dapat menjadi esensial dalam menganalisis karya sastra. Tujuan dari penelitian ini adalah untuk mengetahui bagaimana tokoh utama mempertahankan eksistensi diri dan kebebasannya sebagaimana tercermin dalam novel “Life of Pi” karya Yann Martel. Penelitian ini menggunakan teori wacana eksistensialisme dari Bigelow (1961) dan kebebasan dalam eksistensialisme dari Sartre (2012). Eksistensialisme adalah studi tentang keberadaan, bagaimana diri sendiri mencoba menemukan makna dalam kehidupan yang tidak berarti. Metode penelitian yang digunakan dalam penelitian ini adalah deskriptif kualitatif.. Selanjutnya peneliti menggunakan metode penelitian kepustakaan untuk mengumpulkan data yang terdiri dari sumber data utama dan sumber data kedua dan metode analisis deskriptif untuk menganalisis data dengan menggunakan teori dari Ratna (2009). Terakhir, hasil penelitian akan ditampilkan dengan menggunakan teknik paradigma kualitatif yang dikemukakan oleh Creswell (2013) yang artinya hasil penelitian akan disajikan dengan menggunakan kata-kata dan kalimat. ABSTRACT

Existentialism often becomes one of the prevalent object to exist in literary works and can be essential in analysing literary works. The aim of this research is to find out how main character defend his self-existence and freedom as reflected in “*Life of Pi*” novel by Yann Martel. This research used theory of existentialism discourses by Bigelow (1961) and freedom in existentialism by Sartre (2012). Existentialism is a study of existence, in how oneself tries to find a meaning in this meaningless life. The research method used in this research was descriptive qualitative. Afterwards, the researcher applied the method of library research to collect the data which consist of primary source and secondary source data source and the method of descriptive analysis to analyse the data by using the theory from Ratna (2009). Lastly, the result of the research will be presented using the technique of qualitative paradigm proposed by Creswell (2013) which means the result will be presented using words and sentences. The results of this research found main character struggles and achievement in defending his self-existence, it can be concluded that the main character –Pi— struggles came from its own search of freedom. The struggles faced by the main character found are; existence precedes essences, alienation or estrangement, fear and trembling anxiety, and the encounter with nothingness. its achievement is provided through his effort in overcoming the struggle which are; acknowledgement and self-authenticity.
