ABSTRAK

Penelitian ini membahas tentang systemic functional linguistics yang digunakan dalam pidato Donald Trump mengenai topic terorisme. Tujuan dari penelitian ini adalah untuk menganalisa tipe-tipe dari metafungsi dan fungsi umum yang ditemukan di pidato Donald Trump. Dalam penelitian ini, peneliti melakukan analisa systemic functional linguistics dengan menggunakan teori Suzzane Eggins. Objek penelitian ini adalah metafungsi dan fungsi umum di pidato Donald Trump mengenai terorisme. Peneliti menggunakan penelitian kualitatif dengan metode deskriptif. Data dikumpulkan dengan cara observasi menggunakan teknik non-participant, peneliti melakukan beberapa langkah yaitu menonton pidato, membaca transkrip pidato, dan menulis data yang berhubungan dengan formulasi masalah. Data yang dikumpulkan dikelompokkan berdasarkan tipe dari experiential, interpersonal dan theme. Setelah mengumpulkan data, peneliti menganalisa data menggunakan qualitative deskriptif. Hasil dari penelitian akan dipaparkan dengan verbal deskriptif atau penjelasan yang berbrntuk kata-kata .hasil dari penelitian ini adalah bahwa benar di dalam pidato Donald Trump terdapat tiga jenis metafunction yaitu experiential, interpersonal, dan textual metafunctions yang mana experiential di reprsentasikan oleh material process, interpersonal direpresentasikan menggunakan subjek “we”, dan textual di representasikan oleh topical theme. Hasil dari penelitian ini juga di tambah dengan general function yang mana general function dari pidato ini adalah representatives yang dapat menggambarkan bahwa pidato Donald Trump berisikan tentang fakta-fakta kejahatan yang telah dilakukan oleh teroris, tidak hanya di Amerika namun juga di seluruh dunia. Dengan pidato ini Donald Trump juga mengajak masyarakat Amerika untuk melawan para teroris khususnya yang ada di Amerika

ABSTRACT

This research discusses about metafunction and general function in Donald Trump's speech on terrorism topic. The aims of the research are to analyze the types of metafunction and general function found in Donald Trump's speech. In this research, the researcher does the analyzing of systemic functional linguistics by using Suzanne Eggins' theory. The object of this research is metafunction and general function in Donald Trump's speech on terrorism topic. The researcher uses the qualitative research with descriptive method. The data is collected by observation with non-participant technique, then the researcher does several steps those are watching the speech, reading the speech's transcript, and reading the data found related to the formulations of the problem. The collected data is classified based on three types of metafunction, they are experiential, interpersonal, and textual metafunction, and based on general functions. The result of the research is presented by using verbal description in other words it is presented by explaining with words. After collecting the data, the researcher analyze the data using qualitative descriptive. The result of the research is true that the Donald Trump's speech contains the three types of metafunction, experiential, interpersonal, and textual. They are represented in different ways. In the experiential, Donald Trump tends to use material process. In the interpersonal metafunction, mood is represented by statement, subject by personal pronouns "we", and modality by "will" In Textual metafunction, Donald Trump mostly uses marked topical theme for 10 times from 20 clauses, unmarked topical theme 6 times, and textual theme 4 times. The researcher does not find interpersonal theme in Donald Trump's speech. While the general function used in Donald Trump is representatives which appears 15 times from 20 data, commissive 3 times, expressive 1 time, and declaration 1 time, while directives do not appear in his speech
