CHAPTER I INTRODUCTION

1.1 Background of the Study

Literature in is the expression of human life which reveal the idea of certain situation through the literary work. In connection with ideas of permanent and universal interest, are characteristic or essential features, as poetry, novels, history, biography, drama, short story and essays. Literature is a term used to describe witten or spoken material. Literature is used to describe anything from creative writing to more technical or scientific works, but the term is most commonly used to refer to works of the creative imagination.

There are some kind of literary works such as novel, poetry, short story, and drama. One of literary work which has the expression of human life is novel. A novel is functional piece of prose usually written in a narrative style. Novel is prose fiction written in a narrative and usually written in story form. The contents of the novel is longer and more complex than the content of the short story, and there is no limit structural and rhyme. Novel can be analysed by using some method. In this research researcher

finds that the proper approach to analyze theory to be applied is sociological approach by Alan Swingwood. Alan Swingewood is an academic sociology and politic in London. Alan as an expert of literature study and his theory about sociological in literary works. Swingwood has published major sociology books and One of his famous books about literature word is Sociology of Literature. Allan Swingewood has three concepts or three prespective in analyzing literary works by using Sociological Approach related to social document, authors social condition, and historical moment. Social document means literary work contains social facts or connectivity and similar situation with what happen in the real world. Authors social condition means literary work consist of genuine or having the origin supported by unquestionable evidence. The last is historical moment means literary work contains historical events that supported with what have been described in the literary work.

By applying sociological approach researcher wants to analyze teenager's misbehaviour in the novel as normally found in society. Teenager's misbehaviour is an act that violates the norms, rules, or laws in a society that is done in adolescence or childhood transition to adulthood. It covers all behaviour that deviates from the norms of criminal law. Actions that can be categorized as teenager's misbehaviour are like smoking, fighting, using drugs, getting expelled from school, drinking alcohol, and doing free sex. For teenagers In USA on 50's smoking is a must action they must do to show how gentle they are and so other people can't bothered them. It's more like they are showing off their greatness by smoking. In USA on 50's, teenagers were get used to quarrel or fighting with each other because in that moment there are so many violating songs from rock music

The Catcher In The Rye is written by Jarome David Salinger or J.D Salinger. He was born in Newyork on 1 january 1919. He is the second and the last child of Sol and Marie Jilich Salinger. Like most of Salinger's central characters, the family lived in the relative comfort of the upper-middle class. He was active in drama and singing clubs. At the age of 20, in 1939, Salinger enrolled in a short-story writing course at Columbia University taught by Whit Burnett, a writer and important editor; Salinger sold his first story to Burnett's story magazine for twenty-five dollars the next year. The most popular literary works from J.D Salinger is novel The Catcher In The Rye, some critics argued that the book was not serious literature its use casual and informal tone and J.D Salinger discussed adolescent sexuality in a complex and open way. By using this novel in this research, researcher will determined the factors that may affect of teenager's misbehaviour in 1950s.
