# CHAPTER I INTRODUCTION

### 1.1 Background of the Research

Literature is a written works that contain the expression of an individual life and society. The expression of an individual; opinion, point of view, emotions and aspiration are seen through language in the form of literature. According to (William J Long, 1945), Literature is the expression of life in words of truth and beauty; it is the written record of man's spirit, of his thoughts, emotions, aspirations; it is the history, and the only history, of the human soul. The expression in literature can be conveying through poetry, drama, short story and novel.

The literary work which is going to analyze here is novel. Novel is a branch of literary works which often becomes an interesting object to be analyzed. People may find many things by reading literary works such as novel since its story related to the interaction of human toward their society and environment. According to (Whitla, 2010-60) novel is one of literary works which can be used to make a communication to other people which emotion that bring them into imaginary world. Through novel the writer convey their message to the reader like indirect communication to get the idea about life likeness. In this research, the researcher analyze a novel entitled "Steinbeck's of Mice and Men" to be analyzed. "Mice and Men" is a novel written by author John Steinbeck published in 1937. This book is set during the Great Depression in the 1930s. "Mice and Men" tells story of two displaced migrant ranch workers who move from place to place in California in search of new job opportunities during the Great Depression in the United States. In this period race and gender were very important characteristics that determined whether a person had the opportunity to make money. In this novel, the author demonstrates that man's dream is destined to be destroyed by a cruel reality. That dream is eventually destroyed by an unfeeling, materialistic and modern society. The whole story of "Mice and Men" tells about how the main characters struggle in gaining their dreams.

The researcher chooses "Steinbeck's of Mice and Men" for some reasons. Firstly, the story of "Steinbeck's of Mice and Men" and the autobiography of John Steinbeck is one of many kinds of novel which showed about phenomena of similarity. Researcher also has experience from the characters, the settings and the social conditions which appeared in other novels and have kinds of relation with the real life of society. These phenomena are which want to be analyzed more deeply by researcher, especially about social condition which related in the social life and very important because it is a part of lives. Secondly, novel "Steinbeck's of Mice and Men" is a popular story and a classic from American Literature. This novel shows some of characters feelings about the situations they are being put in. It portrays social condition of American's society during the great depression.

Furthermore, this novel explains about the impossibility of the American Dream; the imbalance of social power structures in American society. Indirectly, this novel tells about the social issues that occur in the society during the great depression.

The writer of novel "Steinbeck's of Mice and Men" is John Steinbeck. He is one of America's most beloved and honored writers. He started his career as a writer when he took a job as a caretaker in "Lake Tahoe". His first work is novel "Cup and Gold". This novel success and quite get good response from the public. "The Grapes of Wrath" is masterpiece of Steinbeck works. This novel won the "Pulitzer Prize" awards in 1940 as the best novel. John Steinbeck's works always closely related to social life, such as "Mice and Men". He describes environment about social condition which is related to sociological study. Steinbeck uses simple words to convey the story to make the reader easy to understand.

Normally, John Steinbeck's works usually related to the social discussion. In the social discussion we learn about sociological study. Sociology is the scientific study of society. This study examines how humans interact with each other and how human behavior is shaped by social structure (Group, Communities and Organization), Social Categories (Age, Race, Gender, Class) and social institution (Politic, Religion, education, etc). One of the founders of modern sociological study is Max Weber. Weber has a great influence on the development of social science in the twentieth century. Weber analyzed the economic, political, intellectual, historical, and religious factors that contribute to modem social realities.

Based the explanation above the researcher concludes that Weber's theory related to this research which analyzes social condition in society. The researcher uses Max Weber sociological approach theory to analyze social condition as reflected from their experiences as a migrant in the novel "Steinbeck's of Mice and Men". Weber's analysis of class is similar to Marx's, but he discusses class in the context of social stratification more generally. Class is one dimension of the social structure beside social status or social honor. Both are significant contributors of social difference. Weber's treatment of class and status indicates the manner in which the material basis of society is related to the ideological. Social conflicts may occur from one or both of them.

Social action is motivated by both of them, though in some cases more one than the other. By bringing in status, Weber provides a more flexible view of the details of social differences, and their implications for the lived experience of social actors. Max Weber theory developed The Three Component theories of stratifications or three class systems. They are class, status and political power (party) as distinct ideas of types. This theory provides flexible view of the details of social differences, and their implications for the lived experience of social actors. Through his theories, he wants to reveals the social differences.

In here, the researcher is interested to conduct a research about social condition of American society during the Great Depression. At that time, American people were in worst economic depression in history. They started losing their homes and had to live on the street. Many American people do not prepared for major economic crisis. The Shock cause by Depression stemmed not

alone from lack experience. Another example of crisis economic happened in the society is crisis economic of Indonesia on 1998 that cause lack of trust to toward government. These phenomena happened in the society because of some factor which influences it. Through social study, people learn and know causes of the economic crisis and how to fill them. Therefore it is important for people to enrich their knowledge about social condition from a society such as social conflict because it is related to the social life and it is part of social life. - The social condition of the Great Depression in the US by American Society in 19<sup>th</sup> century as reflected in "Mice and Men" by John Steinbeck.
