CHAPTER I INTRODUCTION

1.1 Background of the Problem

The word 'literature' derives from the Latin word 'Littera' which means letter. It primarily refers to the written or printed words. Frances began writing to help earn money for the family, publishing stories in magazines from the age of

19. In 1870, her mother died and in 1872 Frances married Swan Burnett, who was a medical doctor. They lived for two years in Paris, where their two sons were born, before returning to the United States to live in Washington D.C., Burnett then began to write novels, the first of which *That Lass o' Lowrie's* was published to good reviews. *Little Lord Fauntieroy* was published in 1886 and made her a popular writer of children's fiction, although her romantic adult novels written in the 180s were also popular.

Beginning in the 1880s, she began to travel to England frequently and in the 1890s bought a home there where she wrote *The Secret Garden*. Her oldest son, Lionel, died of tuberculosis in 1890, which caused a relapse of the depression she has struggled. She divorced Swan Burnett in 1898 and married Stephen Townsend in 1900, and divorced him in 1902. A few years later she settled in Nassau County, Long Island, where she died in 1924 and was buried in Roslyn Cemetery.

In this research, the writer chooses the title "Moral Values Found in "The Secret Garden" by Frances Hodgson Burnett; A Moral Philosophical Approach". The reason of choosing this title because the writer sees the major points of this novel is about children, friendship among friends, respect of every servants to their master, and the feeling affection from the daughter to mother. From the story it can bring some great impacts by reading it, and can be applied to real life in order to be a better person. According to the background above, the writer determines the title of this research is "Moral Values Found in "The Secret Garden" by Frances Hodgson Burnett; A Moral Philosophical Approach". The
