ABSTRAK

Penelitian ini menganalisa tentang karakter dari Cleopatra berdasarkan existentialist feminis . Adapun tujuan dari penelitian ini adalah untuk mengetahui karakter dari Cleopatra dan mengetahui sisi existentialist feminis dari Cleopatra. ABSTRACT

This research analyzes about existentialist feminism of Cleopatra character. The aim of this research are to describe the dominant character of Cleopatra in "Anthony and Cleopatra" and know what existentialist feminism values are reflected in Cleopatra character. Existentialist feminism itself means that woman as an object related with the subject. Women's struggle for equal rights as men. The theory applied in this study is existentialist feminism theory proposed by Simon De Beauvoir. Research method which is applied in this study is qualitative method. For technique of collecting data, the researcher uses documentary research which is divided in two, primary and secondary data. Primary is taken from drama itself, and secondary data is taken from the article of book or internet which is related of existentialist feminism. After having discussion and analysis, the researcher finds that four existentialist feminism values that reflected in the main character, those are tendencies by working, becoming intelects, by transferring the social value into the society, and identify herself the view of dominant group in the society.
