ABSTRAK

Penelitian ini tentang signifikasi puisi The Raven yang di tulis oleh Edgar Allan Poe. Peneliti mengaplikasikan pendekatan Semiotika yang di ambil dari teori Michael Riffaterre. ABSTRACT

This study is about the significance of The Raven poem by Edgar Allan Poe. The Researcher uses the Semiotics approach which is taken from the theory of Michael Riffaterre. This research is a qualitative research with a poem written by Edgar Allan Poe entitled The Raven as the data source and Riffaterre's semiotic as the object of the research. This research applies the primary and secondary data source in method of collecting data. The research result serves by using informal form as the research is in words, phrases, sentences, and paragraph. The research analysis found that there are four types of Displacing of Meaning, two types of Distorting of Meaning, and two types of Creating of Meaning within the poem. The heuristic and hermeneutic readings are used as a comparison of how to interpret the poem from two different perspectives.
