CHAPTER V

CONCLUSION AND SUGGESTION

In this chapter consist of two parts, named conclusion and suggestions. The conclusions are drawn based on the formulation research question of each objective in this research. Beside that in the second part some question provide for some related parties.

5.1 Conclusion

According to the findings and discussion in the previous chapter, some conclusion related to the flouting maxim uttered by main characters in Logan movie can be drawn as follow.

1. Concerning about occurrence of flouting maxim of Grice's cooperative principle theory in main character's utterances in Logan movie, flouting maxim of quantity is used by the main character provide statement which not contains right amount of statement based on what interlocutor asking about. Then, flouting maxim of quality is used in situation the main characters tell the untruth of knowledge about what they know. Next, flouting maxim of relation is used in situations which main characters have not appropriate statement or answer in their utterances toward what interlocutor asking about. Last, flouting maxim of manner is used by the

main characters by giving an ambiguity statement toward interlocutor utterance. The implied meaning of flouting maxim of Grice's cooperative principle theory in main characters' utterances in Logan movie, flouting maxim of quantity has implied meaning which is giving information that meant as signal to the hearer to not continue the conversation . Then, flouting maxim of quality has implied meaning which means to give the untruth information from what speaker's background knowledge. Next, flouting maxim of relation has implied meaning which means to provide information which has no related or not appropriate toward interlocutor utterance. Finally, flouting maxim of manner has implied meaning which means to tell information with an ambiguity that make interlocutor difficult to understand about, it is like challenge to interlocutor on what speaker meant.

2. Concerning about the frequency and percentage of flouting maxim by main characters' utterances in Logan movie, from the seventeen data analysed, the flouting maxim of quantity is used four times, receiving 23%, flouting maxim of quality is used three times, receiving 18%, maxim of relation is used seventh times, receiving 41%, and maxim of manner is used three times, receiving 18%. In line with this, flouting maxim of relation places highest, followed by flouting maxim of quality, flouting maxim of quantity and maxim of manner.

5.2 Suggestion

This research has reached the conclusion. However, it is exactly still far from being perfect, and moreover, demands for further research to be more perfect. After having completed this research, the researcher hopes that the findings from this research will contribute to draw interests for future researchers to conduct further studies concerning the application theory of linguistic studies in wide filed which is not focusing on written object only. Well, some suggestions for further studies are presented as follow:

- The researcher also hopes the future researcher could make this research be wide by finding the data in different object, such as between seller and buyer in different shops, between employees in a company, moreover if it could happen in overseas countries, it would be unique research, especially for linguistic students
- For future researcher should try new things of linguistic study, such as make the research with the same object but, different theory but still in observance maxims.

With the conclusion of the findings described and the suggestions for further studies proposed, the researcher has completed every step is required in her part of research, but for studying about new things will never be end. Learn and learn again.
