

## **ABSTRAK**

Feminisme adalah sebuah gerakan sosial yang bertujuan untuk meningkatkan suara perempuan untuk mendapatkan hak yang sama di masyarakat dengan laki-laki. Penelitian ini akan menemukan perjuangan perempuan untuk mencapai eksistensi dan hambatan yang dihadapi para tokoh dalam mencapainya melalui empat orang anak perempuan Maret dan ibu mereka, yang memiliki kepribadian yang berbeda satu sama lain. Novel "Little Women" digunakan sebagai sumber data dalam penelitian ini karena adanya isu feminism yang terkandung di dalam cerita. Penelitian ini menggunakan feminism eksistensialis yang didasarkan pada teori de Beauvoir (1956) dan didukung oleh Tong (2014) yang memetakan cabang feminism. Penelitian ini menggunakan metode kualitatif. Kemudian, dalam mengumpulkan data, digunakan metode penelitian kepublikan oleh Ratna (2015), meliputi sumber data primer dan sumber data sekunder. Oleh karena itu, analisisnya menggunakan metode analisis deskriptif yang diteorikan oleh Ratna (2015). Hasil dari data yang diperoleh berbentuk deskriptif, yang hanya menggunakan kata-kata atau kalimat untuk menganalisis dan menyajikan data. Temuan dari penelitian ini adalah beberapa perjuangan perempuan untuk mencapai eksistensinya, pertama dengan bekerja, kedua dengan intelektual, dan ketiga dengan menolak "liyan" atau liyan. Selain itu, hambatan yang dihadapi oleh tokoh juga ditemukan sebagian besar karena masyarakat dan budaya. Terdapat dua hambatan, yaitu perspektif masyarakat berdasarkan persepsi budaya dan ketakutan diri terhadap perspektif masyarakat. Oleh karena itu, karakter-karakter perempuan dalam keluarga March, seperti Jo, Meg, Amy, Beth, dan Marmee, merepresentasikan temuan-temuan ini.

## **ABSTRACT**

Feminism is a social movement that aims to increase women's voices to get the same rights in society as men. The research is going to discover the women's struggles to achieve existence and the obstacles that the characters face in achieving it through four March girls and their mothers, who have different personalities from each other. The "Little Women" novel is used as a data source in this study because of the feminism issue contained in the story. This research used existentialist feminism based on de Beauvoir's theory (1956) and supported by Tong (2014), which maps out the branch of feminism. This research uses qualitative methods. Then, in collecting data, the library research method by Ratna (2015) was used, including the primary data source and secondary data source. Therefore, the analysis used the descriptive analysis method theorized by Ratna (2015). The result of the data was in a descriptive form, which only used words or sentences to analyse and present the data. The finding of this research was that several women's struggles to achieve their existence, first by getting to work, second by intellectual, and third by rejecting "liyan" or otherness. Moreover, the obstacles faced by character are also found to be mostly because of society and culture. There are two obstacles, which are the perspective of society based on cultural perception and the self-fear of society's perspective. Therefore, the female characters in the March family, such as Jo, Meg, Amy, Beth, and Marmee, represented these findings.
