

ABSTRAK

Diskriminasi terhadap perempuan dapat diartikan sebagai perlakuan yang tidak setara antara laki-laki dan perempuan, dan hal ini masih sering ditemui didalam kehidupan sehari-hari. Salah satu contohnya adalah perempuan-perempuan di negara Korea Selatan. Sumber data untuk penelitian ini dipilih dari sebuah novel yang berjudul “Kim Jiyoung, Born 1982” oleh Cho Nam-joo. Kim Jiyoung, wanita yang sudah menikah ini digambarkan sebagai wanita subaltern dan merasakan kekerasan sebagai akibat dari diskriminasi gender sejak ia masih muda. Pendekatan utama dalam penelitian ini adalah pendekatan feminism dan metode yang diterapkan adalah kualitatif. Peneliti menjelaskan teori tentang perempuan subaltern berdasarkan teori Spivak (1988), diskriminasi gender berdasarkan teori Rogers (1981) dan Lundberg-Love & Marmion (2006). Penelitian ini bertujuan untuk mengetahui diskriminasi serta kekerasan sebagai akibat dari diskriminasi yang dialami oleh karakter utama dalam novel tersebut, Kim Jiyoung. Hasil-hasil dari penelitian ini menunjukkan bahwa ada delapan data untuk menjawab diskriminasi yang dialami Kim Jiyoung sebagai karakter utama, serta sembilan data untuk menjawab kekerasan yang dialami Kim Jiyoung sebagai akibat dari diskriminasi. Total data yang telah ditemukan adalah tujuh belas data. Peneliti menyimpulkan bahwa ada diskriminasi yang dialami dan kekerasan sebagai akibat dari diskriminasi yang diterima oleh Kim Jiyoung sebagai karakter utama.

ABSTRACT

Discrimination against women can be defined as an unequal treatment between men and women which is still often encountered in everyday life. One of the examples is South Korean women. The data of this research is chosen from a novel entitled “Kim Jiyoung, Born 1982” by Cho Nam-joo. Kim Jiyoung, a married woman who was portrayed throughout the novel as a subaltern woman who suffered because of the patriarchal society since she was still little. The main approach of this research is feminism approach and the applied method is the qualitative method. The researcher explained the theory of subaltern woman by using the theory of Spivak (1988), the theory of gender discrimination by using the theory of Rogers (1981) and Lundberg-Love & Marmion (2006). This research aims to know the discrimination and the violence caused by discriminations experienced by the main character, Kim Jiyoung. The results of this research showed that there were eight that had been found to answer the discrimination experienced by the main character, and nine data had been found to answer the violence as the results of discriminations received by the main character. The total data that had been found are seventeen. The researcher concluded that there were discriminations along with its violence caused by gender discriminations received by Kim Jiyoung as the main character.
