

## CHAPTER V

### CONCLUSION AND RECOMMENDATIONS

#### 5.1 Conclusion

After applying the theories of Rogers (1981) and Lundberg-Love & Marmion (2006) in the novel “Kim Jiyoung, Born 1982” by Cho Nam-joo, the researcher finally formed brief conclusions as there were data that had been found. From conducting the data analysis, the researcher found that there were discriminations experienced by Kim Jiyoung as the main character of the novel “Kim Jiyoung, Born 1982” by Cho-Namjoo. Once the researcher finished reading the novel, the researcher took conclusion that for the discriminations, it was mostly occurred in the family and Kim Jiyoung’s father and grandmother were the ones who were always put the sisters in hard situations. In the form of the discrimination in the workplace, what can be concluded here is it mostly happened when Kim Jiyoung went to a job-fair.

From the violence caused by the discriminations, the researcher took conclusions that Kim Jiyoung mostly received both the emotional and sexual abuses. The emotional abuses were received by the main character when she was still in her school days and Kim Jiyoung’s chair-mate, should had been become the one who was responsible for this case as most of the time, he was the one who put Kim Jiyoung in hard situations. As for the sexual abuses, it was mostly occurred when Kim Jiyoung went to a job interview. The interviewer kept asking the interviewees, including Kim Jiyoung, sexual questions, which later became the reason why she didn’t get the job offer as she answered in the right way.

As for the findings, there were two types of the data that the researcher had concluded to answer the research questions. The first finding that had been conducted is the discrimination experienced by Kim Jiyoung as the main character, and the second one revealed the violence caused by discriminations received by Kim Jiyoung as the main character. For the gender discriminations, the researcher had found eight valid data: seven data occurred in the family, and one data occurred in the workplace. For the violence, the researcher had found nine data: one data for the physical abuse had been found, four data had been found for the emotional abuses, and four data had been found for the sexual abuses. The researcher concluded that there were discriminations experienced along with its violence caused by gender discriminations received by Kim Jiyoung as the main character.

## **5.2 Recommendations**

While analyzing the gender discriminations against subaltern woman experienced by Kim Jiyoung in the novel “Kim Jiyoung, 1982” by Cho Nam-joo, the researcher, faced two obstacles. The first obstacle is the researcher had a hard time in finding the theory by the expert for the gender discriminations experienced by Kim Jiyoung. In the end, the researcher chose the book “The Domestication of Women: Discrimination in Developing Societies” by Rogers (1981). The second obstacle is the researcher once found it hard to find the correct answers for the research questions. Aside from the obstacles, there are also recommendations that the researcher can offer for those who are in need.

As for those who are merely readers and students, this research is expected to be helpful to enrich their knowledge regarding to the discrimination along with its violence as the results of gender discriminations. The researcher hopes that through this research, the readers out there will finally realize that women, who live all over the world, deserve to be treated equally. Also, from the data that have been found, the researcher hopes that the readers and students in general will try to read the novel Kim Jiyong, Born 1982. As for the researchers in the future, the researcher hopes that this research will be able to encourage the next researcher who wants to explore more about feminism approach especially the data that talk about the misogyny that women face. Furthermore, the researcher hopes that the next researchers who want to use the same data will use different theories as there are many theories explained by the other experts.
