## **ABSTRAK**

Penelitian ini bertujuan untuk mengetahui jenis-jenis pelanggaran maksim dalam film. Teori dari Grice (1975) diterapkan sebagai teori utama. Selain itu penelitian ini menggunakan film “Persuasion” sebagai sumber datanya. Deskriptif kualitatif digunakan sebagai metode dalam desain penelitian. Untuk metode dan teknik pengumpulan data penelitian ini menggunakan metode observasional dan teknik non partisipatif yang dikemukakan oleh Sudaryanto (2015). Penelitian ini menggunakan metode identitas pragmatis dan teknik penyetaraan pragmatik dari Sudaryanto (2015) dalam menganalisis data. Hasil penelitian ini menemukan 17 data pelanggaran maksim kuantitas, 10 data pelanggaran kualitas maksim, 5 data pelanggaran hubungan maksim, dan 6 data pelanggaran maksim cara. Tiga pelanggaran maksim yang dominan adalah kuantitas, kualitas, dan hubungan. Adapun pelanggaran maksim yang paling sedikit ditemukan adalah pelanggaran maksim kualitas dengan kemunculan sebanyak 5 di dalam film persuasion.

## **ABSTRACT**

This present research have goal to find out about the types of flouting maxims in the movie. The theory from Grice (1975) was applied as the main theory. Additionally this research used the movie "Persuasion" as the data source. The descriptive qualitative was used as the method in research design. For the method and technique in collecting the data this research applied the observational method and non-participatory technique by Sudaryanto (2015). This research applied the pragmatic identity method and pragmatics in- equalizing techniques from Sudaryanto (2015) in analyzing the data. The result of this study discovered 17 data for flouting maxim quantity, 10 data for flouting maxim quality, 5 data for flouting maxim relevant, and 6 data for flouting the maxim of manner. The three dominant flouting maxims were quantity, quality, and relevant. As for the least flouting maxim found was the flouting maxim of relevant with 5 data in the persuasion movie.
