

ABSTRAK

Penelitian ini bertujuan untuk menemukan tipe-tipe dari mekanisme pertahanan dan motif di balik penggunaan mekanisme pertahanan dalam novel “Anxious People” karya Fredrik Backman. Teori mekanisme pertahanan dikembangkan oleh Sigmund Freud (1989) yang menjelaskan bahwa mekanisme ini merupakan proses psikologis yang digunakan individu untuk melindungi dirinya dari kondisi yang mengancam dan konflik internal. Teori mengenai motif penggunaan mekanisme pertahanan yang dikembangkan oleh Anna Freud (1993) mengungkapkan bahwa kondisi internal dan eksternal mendasari penggunaan mekanisme pertahanan oleh individu. Desain dalam penelitian ini adalah kualitatif oleh Creswell dan Creswell (2018) yang terdiri dari kata, kalimat, paragraf dan tidak berbentuk angka. Penelitian ini menggunakan metode penelitian library research dalam pengumpulan data, yang terdiri dari data primer dan sekunder. Data primer adalah novel itu sendiri dan data sekunder merupakan sumber lain yang mendukung penelitian. Terdapat dua unsur yang dianalisa dalam penelitian, yaitu unsur intrinsik dan ekstrinsik. Hasil dari penelitian ini disajikan secara deskriptif. Penelitian ini menemukan ada delapan tipe-tipe mekanisme pertahanan yang ditunjukkan tokoh utama, yaitu represi, pengingkaran, proyeksi, sublimasi, pembentukan reaksi, perpindahan, regresi dan rasionalisasi. Terdapat tiga bentuk motif yang mendasari kemampuan suatu individu dalam mengaktifkan mekanisme pertahanannya, yaitu objektif, instingtual, dan superego.

ABSTRACT

This research aims to discover the types of defense mechanisms and the motives behind the use of defense mechanisms in “Anxious People” novel by Fredrik Backman. The theory of defense mechanisms was developed by Sigmund Freud (1989) who explained that this mechanism is a psychological process that individuals use to protect themselves from threatening conditions and internal conflicts. The theory regarding motives for using defense mechanisms developed by Anna Freud (1993) reveals that internal and external conditions underlie the use of defense mechanisms by individuals. The design in this research is qualitative by Creswell and Creswell (2018) which consists of words, sentences, paragraphs and is not in the form of numbers. This research uses library research methods in data collection, which consists of primary and secondary data. Primary data is the novel itself and secondary data is another source that supports research. There are two elements analyzed in the research, namely intrinsic and extrinsic elements. The results of this research are presented descriptively. This research discovered that there are eight forms of defense mechanisms shown by the major characters, namely repression, denial, projection, sublimation, reaction formation, displacement, regression and rationalization. There are three forms of motives that underlie an individual’s ability to activate their defense mechanisms, namely objective, instinctual and superego.
