ABSTRAK

Psikologikal merupakan ilmu yang mempelajari permasalahan kesehatan jiwa (mental disease) yang menimpa kehidupan seseorang. Penyakit mental diakui sebagai gangguan psikologis nyata yang dapat terjadi pada siapa saja tanpa memandang usia atau jenis kelamin, dan hampir tidak ada yang memperhatikan. Di antara beberapa permasalahan psikologis yang ada, salah satunya adalah Post-Traumatic Stress Disorder yang sama dengan Anxiety Disorder akibat suatu peristiwa yang terjadi di masa lalu. ABSTRACT

Among the several psychological problems that exist, one of them is Post-Traumatic Stress Disorder, which is the same as Anxiety Disorder due to an event that occurred in the past. This research uses a novel as research material and raises the theme of mental illness from the novel "Eleanor Oliphant is Completely Fine" by Gail Honeyman and uses Freud's theory (1920) to analyze the researcher using Davison and Neale's Theory (1967) for the Post- Traumatic Stress section Disorders. The researcher used the Creswell 2018 qualitative method because the researcher analyzed the data, the researcher used a qualitative method called descriptive qualitative because the researcher used the five senses. The aim of this research was to understand the causes and symptoms of Post-Traumatic Stress Disorder and the relationship between psychology and Post- Traumatic Stress Disorders. The results of this research were the discovery of environmental causes 2, genetic causes 1 and psychological causes 2 and researchers found several symptoms, namely Avoidance symptoms 3, Arousal symptoms 4, and Re-experiencing 3. paves how for readers to reduce her PTSD from traumatic events. This survey also helps readers identify PTSD.
