

## **CHAPTER V**

### **CONCLUSION AND RECOMMENDATION**

#### **5.1 Conclusion**

Based on the analysis and research findings, two primary conclusions can be drawn about the maxim violations discovered in the research, using the theories of Grice (1975) and Christoffersen (2005). First, the research identified four types of maxim violations in the talk show “The Little Big Shot.” These four types are: violations of the maxim of relation, the maxim of quantity, the maxim of quality, and the maxim of manner. There are seven instances of violations of the maxim of relation, six instances of violations of the maxim of quantity, five instances of violations of the maxim of quality, and three instances of violations of the maxim of manner.

Secondly, the conclusion describes to the reasons of violation maxim that appeared in the talk show “The Little Big Shot.” The research provided seven reasons of maxim violations in the talk show. These four reasons are: hide the truth, save face, satisfying the hearer, cheer the hearer, avoiding to hurt the hearer, building one’s belief, and convincing the hearer. There are cheer the hearer emerged as the most frequently used, observed six times in data, then satisfying the hearer and convincing the hearer each appear five times in data. Thus, building one’s belief occurred twice in data. Meanwhile, hide the truth, save face, and avoiding to hurt the hearer, each occurred once in data. While feel jealous about something it is not found in this data source, due to children featured on the show are often chosen for

their exceptional abilities or achievements, which are typically viewed positively. Jealousy among children might be less visible.

Moreover, the violation maxim of relation is the most frequently occurred. These violations are frequently observed because the children's natural communication style and the show's entertainment goals contribute to the frequent occurrence of these types of maxim violations. Furthermore, cheer the hearer as the most frequently used because the show aims to create an enjoyable and entertaining atmosphere. the primary participants, often share funny, charming, or unexpected responses to amuse the audience and keep the conversation entertaining. Overall, one challenge was determining the speaker's intent behind each violation, as this requires interpreting context and non-verbal cues, which are not always straightforward. Another challenge was distinguishing between violations that are intentional and those that might occur naturally in spontaneous speech, which required careful consideration of the conversational context.

## **5.2 Recommendation**

Future research could benefit significantly from expanding the scope of analysis beyond the talk show "The Little Big Shot." By including a wider variety of talk shows, as well as other genres such as news interviews, reality show, and scripted programs, researcher can determine if the patterns of maxim violations observed in this study are consistent across different contexts. This broader approach would provide a more comprehensive understanding of how conversational maxims are adhered to or violated in various communicative environments. Additionally, future studies should delve deeper into the maxim

violations. A deeper exploration into the psychological and social motivations would provide a richer understanding of the complexities involved in conversational dynamics.

Future researcher should consider expanding their analysis to a wider range of talk shows and other media formats. In today's era, podcasts and similar shows have become increasingly popular. These platforms often feature extended, unscripted conversations that provide rich data for analyzing maxim violations. Researchers should explore these modern media formats to gain deeper insights into conversational behaviors. Modern research benefits greatly from digital tools and platforms. Social media analytics, transcription software, and other digital tools can streamline the process of collecting and analyzing conversational data. Researchers should familiarize themselves with these tools to enhance the efficiency and accuracy of their studies. Additionally, digital platforms can facilitate collaboration and data sharing among researcher, promoting a more integrated and comprehensive approach to studying conversational violation maxim.
