

ABSTRAK

Penelitian ini bertujuan untuk mengkaji fenomena linguistik khususnya tindak representatif dan fungsi struktural ujaran dalam film "The Social Network". Teori tindak tutur yang digunakan dalam mengkaji fenomena kebahasaan ini adalah teori Searle dan Vanderveken (1985) yang merupakan pengembangan dari teori J.L Austin. Teori ini menunjukkan bahwa tindakan representatif adalah tindakan yang merepresentasikan pendapat seseorang tentang dunia dan mengklasifikasi tindakan-tindakan tersebut dalam beberapa tipe. Tipe-tipe ini yang diteliti dalam film tersebut. Kemudian dalam meneliti fungsi struktural, peneliti menggunakan teori Yule (2010). Penelitian ini merupakan penelitian kualitatif dimana data yang diteliti adalah ujaran. Ujaran-ujaran tersebut merupakan data yang dikumpulkan dengan metode observasi. Untuk metode analisis data, peneliti menggunakan metode padan referensial yang dikemukakan oleh Sudaryanto (2015). Semua data yang dianalisis disajikan dengan metode informal. Cara penyajian informal adalah penggunaan kata-kata atau paragraf untuk menyampaikan hasil analisis data. Teori yang digunakan dalam menyajikan analisis data adalah teori Sudaryanto (1993). Dalam penelitian ini, peneliti menemukan sepuluh jenis tindak representatif, yaitu menegaskan, mengklaim, menyatakan, menggambarkan, menyarankan, membuat hipotesis, menyangkal, meyakinkan, mengingatkan, dan memuji. Di antara jenis-jenis tersebut, yang paling banyak muncul adalah mengklaim. Alasan mengapa tindak tutur mengklaim paling banyak muncul adalah karena tokoh-tokoh dalam film ini menyampaikan pendapat yang cenderung subjektif dan parsial. Selain itu, sebagian besar adegan dalam film ini terjadi dalam persidangan yang membuat para tokoh mempertahankan pendapatnya masing-masing. Selanjutnya, hasil analisis pada fenomena fungsi struktural hanya menunjukkan dua jenis fungsi, yaitu imperatif dan deklaratif.

ABSTRACT

This research aims to examine linguistic phenomena especially representative act and structural function of utterances in the movie "The Social Network". The speech act theory used in examining this linguistic phenomenon is the theory of Searle and Vanderveken (1985) which is a development of J.L Austin's theory. This theory shows that representative acts are actions that represent a person's opinion about the world and classify the actions into several types. Then these types are examined in the movie. Then in examining structural functions, researchers use Yule's theory (2010). This research is a qualitative research in which the data studied are utterances. The utterances are data collected by observation method. For data analysis method, the researcher used referential method proposed by Sudaryanto (2015). All data analyzed in the analysis are presented with informal method. Informal presentation way is the use of words or paragraphs to convey and explain data analysis findings. The theory used in presenting the data analysis is Sudaryanto's theory (2015). In this study, the researcher found ten types of representative acts, namely asserting, claiming, stating, describing, suggesting, hypothesizing, denying, assuring, reminding, and praising. Among these types, the number that appears the most is claiming. The reason why claiming acts appear the most is because the characters in this movie convey opinions that tend to be subjective and partial. In addition, most of the scenes in this movie take place in trials that make the characters defend their own opinions. Furthermore, the results of the analysis on the phenomenon of structural functions show only two types of functions, namely imperative and declarative.
