ABSTRAK

Penelitian ini bertujuan untuk menganalisis pembacaan teks secara dekonstruksi dalam novel "The Goldfinch" karya Donna Tartt. Penelitian ini menggunakan pendekatan dekonstruksi Derrida (1976). Penelitian ini berfokus kepada dua konsep yaitu oposisi biner sebagai strategi pembacaan teks dan kontradiksi internal teks sebagai hasil dari pembacaan teks terhadap karakter-karakter utama dalam novel The Goldfinch. Konsep oposisi biner mencakup difference, teks, dan diseminasi. Setelah melakukan strategi pembacaan teks tersebut, maka akan didapatkan hasil berupa kontradiksi internal teks yang terdiri dari invensi dan teks mendekonstruksi dirinya sendiri. Penelitian ini menggunakan metode deskriptif kualitatif. Peneliti menggunakan metode dokumentasi dalam proses analisa data. Data dikumpulkan dalam bentuk kalimat, penggambaran, dan narasi yang berkaitan dengan konsep dekonstruksi. Dalam penelitian ini, peneliti menemukan dua poin yang berkaitan dengan analisa dekonstruksi karakter utama. Pertama, adanya dua sisi yang berlawanan antar karakter-karakter utama yang dapat diungkapkan secara mendetail dan berbeda dengan pembacaan biasa yang disebut sebagai oposisi biner. Dua sisi yang berlawanan tersebut adalah baik – buruk, asli – palsu, perhatian – cuek, dan bertanggung jawab – lalai. Kedua, hasil dari pengungkapan dua sisi antar karakter-karakter utama akan menghasilkan suatu pandangan yang baru dan tidak terpengaruhi dengan pandangan lama yang disebut sebagai kontradiksi internal teks. Hasil dari pandangan tersebut adalah bahwa pandangan umum yang ada dalam masyarakat tidak bisa menjadi patokan seutuhnya dalam menilai karakter seseorang.

ABSTRACT

This study aimed to analyse the deconstruction reading of the text in Donna Tartt's novel "The Goldfinch". This study used Derrida's (1976) deconstruction approach. This study focused on two concepts, namely binary opposition as a text-reading strategy and internal contradiction text as the result of the reading text of the main character in The Goldfinch novel. The concept of binary opposition included difference, text, and dissemination. After applying the text-reading strategy, the result will be an internal contradiction text which consists of invention and text deconstructing itself. This research used descriptive qualitative method. Researcher used the documentation method in the data analysis process. The data were collected in the form of sentences, descriptions, and narratives related to the concept of deconstruction. In this study, the researcher found two things related to the deconstruction analysis of the main character. First, there were two opposites between the main characters that can be expressed in detail and differ from the usual reading which was called binary opposition. Two opposites were good - bad, original - fake, caring - ignorant, and responsible - irresponsible. Second, the results of two-sided disclosures between the main characters will produce a new perception that was not influenced by the old perception which is called the internal contradiction text. The result of this perception was that the general perception that exists in society cannot be a complete benchmark in assessing a person's character.
